### Call to Order: David Kuhnen – Security Committee Chair 11:06 am

I. Welcome – *Introductions for first-time attendees.*

II. **Public Comment** (3 Minutes per commentary) *Al Cervantes mentioned speeding on Winona. Informed that CHP is best to address. Ron recommended calling and asking for a Bike patrol to post with radar. Al's wife Elizabeth is concerned with prostitution near their home. Sherriff working with trafficking task forces to clean up and apprehend the Pimp's (exploiters)*

III. **Executive Director Comments** —Jhason Wint

- *Asked about Citizens' arrest and CNO(Chronic Repeat Offender) 10 citations= jail w/&10k bail. As a citizen, we can record the crime and call the sheriff. They watch footage verifying crime and even hours later can go cite and/or arrest! Executive Director Jhason Wint was very excited about this clarification and wants to be sure the PBID knows about it. Important that people know that CAN do something about crimes they witness. NOTE: ALL potential liability falls to the reporting party in this case, NOT the sheriff! Verified by Ron Linthicum.*

IV. **Updates & Discussion:**



- District Attorney's Office: Ron Linthicum. *In addition to participating in the above conversation, reiterated changes to policy regarding misdemeanor offenses. Officer discretion to take offenders into custody now. Also 10 Citations w/in 12 month period = jail with \$10k bail. Citing for trespass, drugs, theft etc. 2 of the same infractions in 30 days can be bumped up to a misdemeanor Advised to allow trespassers to be cited by officers.*
- Bissell Bros Maintenance update: *Jhason Wint gave the report \$509.25 SAVED in dump fees with voucher!*
- Sacramento Sheriff: *Everyone should have the Sac County 311 app to report lights out and other things they see and find ( ←See Sidebar)*
- Sacramento Sheriff/POP team: *Continuing to work sting-ops. Takes 2-3 months to plan one op.*
- Sacramento Sheriff HOT team: *Melissa Props-Working aggressively to enforce CNO's. Invited Jhason Wint to get together and go over all current laws and how they can be enforced and what citizens can do to best help.*
- CHP/ POP team:
- Sacramento Police Department/ Regional Transit/ Park Department : *Bus/ train station is being revamped to make the ramp even with trains. Focusing on repeat offenders on rail.*
